General Safety Rules

The purpose of this safety brochure is to inform you of the basic safety rules that you must adhere to while at any facility under Amerequip's ownership.

- All visitors must read and agree to follow the facility safety rules. Contact the Environmental, Health, and Safety Department or Human Resources with any questions or concerns.
- 2. All visitors must sign in and out at the entrance they enter into.
- 3. Safety glasses with side shields that meet the ANSI Z87.1 must be worn in all production areas of the facilities.
- 4. Safety shoes are required to be worn in all production areas unless staying inside the designated pedestrian aisles. The shoes must meet the ASTM F2413-18 standard. Under no circumstance are open-toed shoes allowed on the production floor.
- Hearing protection is required when working in the Weld, Fabrication, and Paint Booth for 30 mins or more. It is also required when using impact or air driven tooling.
- 6. Task appropriate hand protection shall be worn.
- 7. No earphones, earbuds, or headphones allowed on the shop floor. Radios are permitted if they do not distract, irritate, or present a safety hazard to others working in the area.
- The use of cameras is prohibited unless your Amerequip representative approves.
- 9. Do not block exits, emergency equipment, eyewash units or pedestrian aisles.
- Confined spaces are only to be entered if you have the proper training for entry into the space and the permit is filled out prior to work beginning. Contact Maintenance for permits.

- 11. Fall protection must be worn when working at heights above four feet. Area of work should be coned or taped off based on hazards identified.
- Never walk or work under any material suspended from overhead lifting equipment. Use lifting device or team lift anything weighing over 51 lbs.
- Cutting and hot work permits must be filled out prior to work being started. Permits can be acquired from Maintenance.
- 14. Do not remove or tamper with any locked out/ tagged out equipment.
- 15. All employees or visitors must report any unsafe conditions or injuries.
- 16. Contractors must use their own equipment unless arrangements have been made with maintenance in advance.
- 17. No earrings that dangle below the ear lobe are allowed on the production floor.
- 18. Firearms and other weapons are prohibited inside of Amerequip facilities.
- 19. All visitors must have a site contact. Site contact is responsible for their visitors and their safety.

These rules are not all inclusive and do not cover all the rules of Amerequip. There are more specific guidelines for employees laid out in the employee handbook.

Fire Emergency Situation

- 1. If there is a fire emergency and the alarm is sounding, exit the facility at the nearest exit and proceed to the muster area.
- 2. If you are the first person to witness a fire, there are pull stations located at every exit of the facility.
- 3. Visitors are not to attempt to put out a fire with a fire extinguisher.
- 4. Visitors should report to their site contact once in the muster area.
- 5. Do not leave the muster area and wander the site.
- 6. Only re-enter the facility after clearance has been given by the fire department, Incident Commander, or manager.
- 7. Refer to Fire Evacuation Map for muster areas.

Severe Weather Emergency Situation

If there is severe weather or a tornado warning issued for the area the following will happen:

- 1. An announcement will be made over the plant PA system.
- 2. Once the warning is issued for the area, you will proceed to the designated severe weather shelters.
- 3. If you are not with your site, contact inform the Emergency Response Team member who your site contact is for your roll call.
- Once the severe weather or tornado has passed the Emergency Response Team will find a safe path out in the event of damage to the facility.
- 5. Refer to the Severe Weather Muster Map to know your closest shelter.
- 6. Muster Areas:
 - a. Training Center
 - b. Bathrooms- Pre-Hang
 - c. Bathrooms- Weld
 - d. Bathrooms- Fab
